From newbie to buddy

The Milton family came to the Pullum Family Y seeking help raising their great-grandchild, Tanyah, age 8. At ages 67 and 56, they were overwhelmed with everything from the financial responsibility to discipline to personal care

The Y staff jumped in, offering everything from financial assistance with program fees to behavior guidance and even tips for biracial hair care.

Now Tanyah does it all: afterschool, soccer, camp, cheerleading, and basketball. She helps with cleanup and likes to read to younger kids. She even serves as a

"buddy" to others who are new, welcoming new participants into our youth programs.

The Miltons are grateful that the Y "takes so much off our shoulders." As for Tanyah, she ticks off what she loves about the Y: making new friends, having the best counselors, getting help with homework, and playing new games.

Moving to the Panhandle became much easier because of the home-away-from-home she's found at the Pullum Y.



Our afterschool and summer day camps welcomed 733 youth delivered 10,790 units of service. These youth stayed safe, physically active and mentally engaged during out-of-school times.



About one in four youth in our afterschool programs receives Y Assistance that makes it possible for them to have a safe, enriching place to enjoy.



We delivered 1,258 swim lessons to youth of all ages, reducing the likelihood of a drowning in an area surrounded by water.



We modeled healthy habits, teamwork and good sportsmanship to **824 children** in our youth sports programs.



We welcomed 16,236 visits to our KidZone areas inside the Y, giving kids an engaging and safe place to play and giving their parents the opportunity to





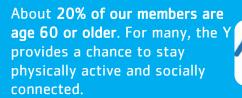


HEALTHY LIVING

We gave away \$204,039 in membership—serving 1,542 people—as part of our commitment to serving all.



In partnership with the Escambia County Department of Health, we welcomed 25 participants to the Wisewoman Program. These women collectively logged nearly 600 visits, rating us high in staff care and the program being a personalized, educational opportunity.

My new playground

Pensacola native Pam Wright was minutes away from a heart attack in 2018, an event that changed her life. "I had been saying I wanted to live healthy, eat right, and exercise," she said. "That experience took me to a new place, and I realized that I have to do this."

She had heard about the Y from others, and she knew she didn't want to take her wellness journey alone. So she joined the Wisewoman program that the Bear Levin Studer Y offers in partnership with the Escambia County



Health Department. The program targets women in her age group who are at risk of heart attack and cardiovascular disease. Pam was introduced to Wellness Coach Melanie Paul, who, she said, "was so great and understanding."

After completing the 12-week program, Pam became a member of the Y and began working on her own in March 2021. Now she's a regular in Senior Fit classes, or you can find her on a

recumbent bike, pedaling away. She said she was nervous at first to join a class, but other members cheered her on in a way she had never experienced.

"I feel great!" she says, calling the Y her "new playground." She credits the support of the Y with pushing her to success.

Supporting recovery

If we've learned anything lately, it's to expect the unexpected. The destruction caused by Hurricane Sally in September 2020 was yet another unexpected blow in an already chaotic year. In the immediate aftermath, your YMCA once again pivoted – this time providing hot showers and overnight accommodations to hundreds of linemen, tree service crews, and logistics professionals working overtime to restore power to our community.

When 7,000 additional workers descended upon Northwest Florida on incredibly short notice, Gulf Power was scrambling to make arrangements for them all.



"The YMCA has provided critical services for over 140 years, and when the opportunity presented itself to help our community by providing

shelter for out-of-town lineman, I didn't need to think about it," said CEO Michael Bodenhausen. "This was a flashback to when the Pensacola YMCA provided the USO, Navy and sailors from all over the world a place to stay."

After working 16-hour days, the men and women who stayed at the Y were grateful for a hot shower, quiet and spacious sleeping arrangements, and a chance to recharge not just their devices but also themselves.



We welcomed 444 donors who gave \$176,221 to our Annual Campaign, led by nearly 90 banner donors who each gave \$1,000 or more to support the Y's mission.



We provided an avenue for members and friends to give back, as 125 people gave volunteer time valued at \$111,450 to make our programs possible.



As part of our commitment to community safety, we **trained 75 new lifeguards** to serve at our pools and other aquatic venues in the area.



We opened our doors to faith groups, other nonprofits, youth development organizations, health care partners, schools, and civic organizations, giving away \$111,877 in facility use so that others could accomplish their goals.

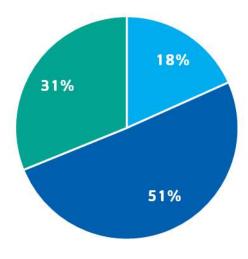

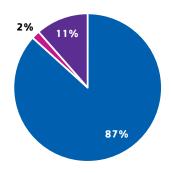
